Methods and materials for containment and cleaning up

Large spill : Stop leak if without risk. Move containers from spill area. Take up by mechanical means preferably by a vacuum cleaner equipped with HEPA filter. Flush remainder with plenty of water. Avoid splashing, high pressure washing or compressed air cleaning to avoid formation of aerosols. Ensure sufficient ventilation. Wash contaminated clothing.
